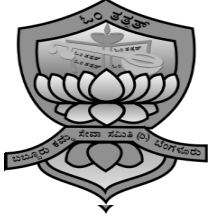

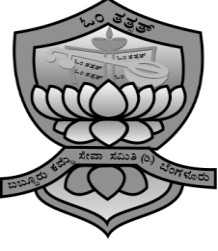

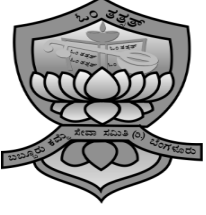

Terms and conditions

- 1) Persons getting salary, pension or getting rent from Property or Financial support from any other sources are not eligible.
- 2) In the case of husband and wife, only any one of them will be eligible for this benefit.
- 3) Completed applications received on or before 31st MARCH of each year will be considered for the next financial year.
- 4) Persons who are given old age pension are required to send Life Certificate each year in March to reach Babboorkamme Seva Samithi Bangalore by 31st MARCH without fail, to get full benefit of 12 months. If Life certificate is received after 31st March, Pension will be with effect from the date of receiving the Life certificate.
